1.) The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy parasite free and up to date with inoculations, proper nutrition, which consists of a good quality feed given at regular intervals, and fresh water

2.) The Seller guarantees this puppy to be of sound health and temperament at the time of the sale. A health record of all shots and/or worming will be provided by the Seller. Buyer agrees to take puppy to a licensed veterinarian of their choice within 1 week for a physical examination. Should the puppy be determined to be in ill health, the

3.) This puppy is sold as a pet/companion only and spay/neuter is mandatory. We require it done no earlier than 4 months and no later than one year. We require receipt of documentation from a veterinarian that these services were completed according to the above stated schedule. This puppy must be spay/neutered by no later than _____. Per agreement with this litter, you will receive \$_____ to reimburse you for your spay/neuter

4.) If at any time the buyer can no longer retain possession of this puppy, the Seller is to be notified and given first option of resuming full ownership of puppy in order for the Seller to locate this puppy a new home. Refunds, if any, will be at the discretion of the Breeder/Seller. Should any circumstances arise that affect the quality of

available at all times. The Buyer promises to provide a safe environment for the dog and to never allow the dog to roam freely without proper fencing or supervision. The Seller strongly recommends that the puppy be microchipped in order to facilitate his/her return if lost or stolen.
